MINIMUM QUALIFICATIONS:

- Six (6) months experience in urban tree maintenance, pruning and large tree removal.
- Valid Class B Commercial Driver License (CDL) with air brake endorsement (must obtain Florida Class B CDL with air brake endorsement within thirty (30) days of employment) OR Proof of completion of written portion (valid permit) of Class B CDL with air brake endorsement. Must obtain Florida Class B CDL with air brake endorsement within ninety (90) days of employment. Note: Permit holders will be hired at 5% less the minimum hiring range until license is obtained.

Driving history for the past three (3) years must reflect no violations of a driving related offense, <u>or</u> driving under the influence (DUI) which includes both drugs and alcohol, reckless driving, or hit and run involving an occupied vehicle or attended property, <u>or</u> an accumulation of traffic violations, plus three (3) points for each attendance at driving school (regardless of whether points were assessed against the license) where the penalty points do not exceed twelve (12).

PREFERABLE QUALIFICATIONS:

- High school diploma or G.E.D.
- Completion of the following NIMS Courses:
 - o Basic IS-700 (6 months)
 - o Basic ICS-100 (6 months)

POSITION FUNCTION:

Prune and remove trees, using hydraulic equipment. Assist with other projects as deemed necessary.

Tasks/Duties of Tree Maintenance Worker

Below is a summary of the Tasks and Duties of this position. For a listing of duties and responsibilities for this position, please see the Job Specification/Demands Analysis included with the posting in the City Hall lobby.

TASK/DUTY

Operate hydraulic tree trimming equipment, various chain saws in pruning and removing large trees, use equipment from the bucket truck at various heights and angles.

Drive and operate a bucket truck with aerial boom.

Assist other divisions with the use of the bucket truck (air conditioner repair, athletic field light replacement or repair, etc.).

Lift heavy tree limbs, stooping, and hauling heavy materials and work long periods of time in awkward positions.

Assist with performing maintenance worker duties including mowing, using Bobcat or hand digging for grade adjustments, preparing areas for removal or planting of trees, shrubs, annuals, sod, rock decoration and irrigation work.

Assists with miscellaneous projects associated with Special Events, hanging up decorations, replacing light bulbs in parks, driving vehicles to auction, meeting beekeepers to spray/remove bee hives and any other projects deemed necessary by the supervisor.

Perform additional duties as assigned. Be available for emergency call-outs.

NOTE:
