#### MINIMUM QUALIFICATIONS:

- Computer literacy to include word processing, spreadsheet, email, and Internet experience within a Windows OS.
- Three (3) years progressively responsible management experience, including direct supervision.
- Level C or higher drinking water <u>or</u> wastewater treatment plant operator certification issued by the Florida Department of Environmental Protection.
- Valid driver license. Must obtain Florida driver license within thirty (30) days of employment.

Driving history for the past three (3) years must reflect no violations of a driving related offense, <u>or</u> driving under the influence (DUI) which includes both drugs and alcohol, reckless driving, or hit and run involving an occupied vehicle or attended property, <u>or</u> an accumulation of traffic violations, plus three (3) points for each attendance at driving school (regardless of whether points were assessed against the license) where the penalty points do not exceed twelve (12).
